- (d) two Platoons Formed Police Unit with 30 percent female representation;
- (e) Armored Vehicles to support peacekeeping operations; and
- (f) increase in the deployment of UN Police Personnel (UNPOL), contingent upon meeting the UN's recruitment standards.

These humble contributions reflect Malawi's longstanding dedication to regional and global peace initiatives. Our active involvement in missions, such as the United Nations Organization Stabilization Mission in the

Democratic Republic of the Congo (MONUSCO) and the Southern African Development Community Mission in the Democratic Republic of the Congo (SAMIDRC) demonstrates our commitment to maintaining peace and stability in the region. We are confident that these resources will enhance capacity to operate effectively in challenging environments and ensuring the safety and security of personnel during missions as well as reinforce Malawi's dedication to contributing to global peace efforts and upholding the rule of law in conflict zones.

These noble commitments underscore Malawi's unwavering dedication to peacekeeping and regional collaboration, reinforcing our role as a proactive contributor to global and regional stability.
